**Terms and Conditions:**

1. Quotations and other requirements shall be submitted to the Bids and Awards Committee.
2. Bidder shall submit the following requirements:
  - a. Valid and current Mayor's Permit/Municipal License
  - b. SEC/DTI Certificate of Registration
  - c. Tax clearance
  - d. PhilGEPS certificate of registration
  - e. Duly signed Quotation Form
3. Quoted prices shall be inclusive of applicable taxes and shall be firm and valid for a period of at least Sixty (60) days from the date of receipt of quotation.
4. Quotations shall be compared and evaluated on the basis of the following criteria:
  - a. Completeness of submission
  - b. Compliance with instructions
  - c. Price

A Bidder who accepted a contract but failed to deliver the required goods called for in the contract or Purchase Order (P.O.) shall be ground for cancellation of the contract or P.O. issued to bidder and shall be disqualified from participating in future NMIS procurement activities. This is without prejudice to the imposition of other sanctions prescribed under RA 9184 and its IRR, against the supplier.
