Invitation to Bid for Supply and Delivery of Phone Tablet

1. The **National Meat Inspection Service (NMIS)**, through the **General Appropriations Act (GAA)** intends to apply the sum of **One Million Pesos (Php1,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Phone Tablet**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *National Meat Inspection Service* now invites bids for **Supply, Delivery of Phone Tablet**. Delivery of the Goods is required on or before **December 2015**. Bidders should have completed, within *one year* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from **NMIS** and inspect the Bidding Documents at the address given below during **office hours**.

A complete set of Bidding Documents may be purchased by interested Bidders on **October 19, 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount as indicated per lot.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the **nonrefundable fee** for the Bidding Documents not later than the submission of their bids.

5. ***The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents:***

The **NMIS** will hold a Pre-Bid Conference on **October 23, 2015, 10:00am** at **NMIS LD Conference Room, Visayas Avenue, Diliman, Quezon City**, which shall be open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the address below on or before **November 6, 2015 at 10:00am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

The NMIS reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, or not award the contract when it will not redound to the benefits of the employees as when the source of funds for the project has been withheld or reduced through no fault of NMIS, without thereby incurring any liability to the affected bidder or bidders.
