INVITATION TO BID FOR Supply and Delivery of Laboratory Equipment II

1. The **National Meat Inspection Service (NMIS)**, through the **General Appropriations Act (GAA)** intends to apply the sum of **Seven Million Seventy Thousand Pesos (PhP7,070,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Laboratory Supplies II**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **NMIS** now invites bids for the following lots:

Delivery of the Goods is required on or before **December 2015** or earlier. Bidders should have completed, **at least one (1) year** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from **NMIS** and inspect the Bidding Documents at the address given below during **office hours**.

A complete set of Bidding Documents may be purchased by interested Bidders on **October 9, 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount as indicated per lot.



The production of clean, wholesome, healthy and sound meat for food is the concern of everyone.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. ***The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents:***

The NMIS will hold a Pre-Bid Conference on ***October 14, 2015 at 09:30am at NMIS LSD Conference Room, Visayas Avenue, Diliman, Quezon City***, which shall be open only to all interested parties who have purchased the Bidding Documents.

6. Bids must be delivered to the BAC Office on or before ***October 28, 2015 at 09:30am***. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on ***October 28, 2015 at 10:00am*** at NMIS Conference Hall, Visayas Avenue, Diliman, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The NMIS reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, or not award the contract when it will not redound to the benefits of the employees as when the source of funds for the project has been withheld or reduced through no fault of NMIS, without thereby incurring any liability to the affected bidder or bidders.
