***Invitation to Bid for Construction of Fence, Gate and Retaining Wall of NMIS-RTOC IX New Office Building***

1. The *National Meat Inspection Service*, through the *GAA FY 2016*, intends to apply the sum of **Seven Million Nine Hundred Ninety Six Thousand Five Hundred Twenty One Pesos and Eighty One Centavos (Php7,996,521.81)** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Construction of Fence, Gate and Retaining Wall of NMIS-RTOC IX New Office Building***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *National Meat Inspection Service* now invites bids for ***Construction of Fence, Gate and Retaining Wall of NMIS-RTOC IX New Office Building***. Completion of the Works is required **One Hundred Twenty (120) calendar days**. Bidders should have completed, within **two years (2)** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from *National Meat Inspection Service* and inspect the Bidding Documents at the address given below from 8:00am – 5:00pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (Php10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. ***The Procuring Entity intends to limit the Pre-Bid Conference to Bidders who have purchased the Bidding Documents:***

The National Meat Inspection Service will hold a Pre-Bid Conference on **July 28, 2016, 10:00am at NMIS Laboratory Conference Room, No. 4 Visayas Ave., Brgy. Vasra, Quezon City** which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to the address below on or before **August 11, 2016, 9:50am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **August 11, 2016, 10:00am at NMIS Laboratory Conference Room, No. 4 Visayas Ave., Brgy. Vasra, Quezon City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The National Meat Inspection Service reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
