



WHEREAS, the **National Meat Inspection Service** advertised the Invitation to Bid for the **Supply and Delivery of Probe Thermometer**, which was posted on the NMIS and PhilGEPS websites and in a conspicuous place in the premises of the NMIS on April 18, 2023 with a total approved budget for the contract (ABC) amounting to **Two Million Two Hundred Sixty-five Thousand Pesos (Php 2,265,000.00)** under the GAA 2023 fund;

WHEREAS, the deadline for submission of bid/quotation was on May 9, 2023 (Tuesday) at 9:20 a.m.;

WHEREAS, in response to the aforementioned advertisements, one (1) bidder purchased the bid documents;

WHEREAS, during the opening of bids on May 9, 2023 (Tuesday) at 9:30 a.m. at the NMIS Conference Room. Three (3) bidders submitted the bid proposal for the **Supply and Delivery of Probe Thermometer**;

WHEREAS, the NMIS-BAC first opened the eligibility and technical documents of **ACEZ INSTRUMENTS PHILIPPINES CORPORATION**, its itemized content was read as shown through a multimedia projector, and it was found to have **PASSED** the “pass or fail” criteria as specified in the bid documents and was declared **“ELIGIBLE”**;

WHEREAS, the BAC proceeded to open the Eligibility and Technical Documents of **MARKEN WEIDA CORPORATION**, its itemized content was read as shown through a multimedia projector, and it was found to have **PASSED** the “pass or fail” criteria as specified in the bid documents and was declared **“ELIGIBLE”**;

WHEREAS, the BAC proceeded to open the Eligibility and Technical Documents of **KEYSTONE INSTRUMENTS CORPORATION**, its itemized content was read as shown through a multimedia projector, and it was found that failure to provide the information to **at least one (1) completed contract similar** to the project, equivalent to at least fifty percent (50%) of the ABC in **“Section II. Instructions to Bidders, Item 5.3”** of the bidding documents, was declared **“INELIGIBLE”**;

WHEREAS, the BAC proceeded to open the financial documents of **ACEZ INSTRUMENTS PHILIPPINES CORPORATION** and **MARKEN WEIDA CORPORATION**; the financial proposal was opened and read as shown through a multimedia projector;

WHEREAS, upon detailed evaluation of financial proposals, **ACEZ INSTRUMENTS PHILIPPINES CORPORATION** was identified as the lowest calculated bid. Consequently, the NMIS-BAC instructed the TWG to assist in further evaluating the bid submitted by **ACEZ INSTRUMENTS PHILIPPINES CORPORATION**. Attached is the Abstract of Bids.

WHEREAS, the Technical Working Group submitted its detailed bid evaluation dated May 31, 2023, which was received by the BAC Secretariat on June 19, 2023. The TWG Evaluation Report is attached.

WHEREAS, after the conduct of a post-qualification assessment, the Technical Working Group found the bid of **ACEZ INSTRUMENTS PHILIPPINES CORPORATION** to be responsive and most advantageous to the government;

WHEREAS, the BAC/TWG conducted validation/verification of all the requirements submitted by the bidder, and thereby certifies its authenticity;

WHEREAS, premises considered, the Bids and Awards Committee hereby resolves to recommend the award of the contract to **ACEZ INSTRUMENTS PHILIPPINES CORPORATION** for having been submitted as the lowest calculated and responsive bid in the amount of **One Million Four Hundred Nine Thousand Seven Hundred Thirty-Six Pesos (Php 1,409,736.00)**.




