WHEREAS, the NMIS-BAC first opened the eligibility and technical documents of GRB Enterprises, Inc., its itemized content was read as shown through a multimedia projector and found to have PASSED the "pass or fail" criteria as specified in the bid documents and was declared "ELIGIBLE";
