This is to inform you that the submission for application for 2025 Eligibility Certification to import Indian Buffalo Meat (IBM) is now open. In pursuant to Section 4 of the Department of Agriculture (DA) Administrative Circular No. 1 series of 2017 on Updated Rules and Regulations Governing the Allocation, Importation and Utilization of Fresh Buffalo Meat from India and its amendments, you may now submit the documents required to be evaluated by the IBM Technical Working Group (TWG).

Applications submitted after July 31, 2024 will not be accepted.
