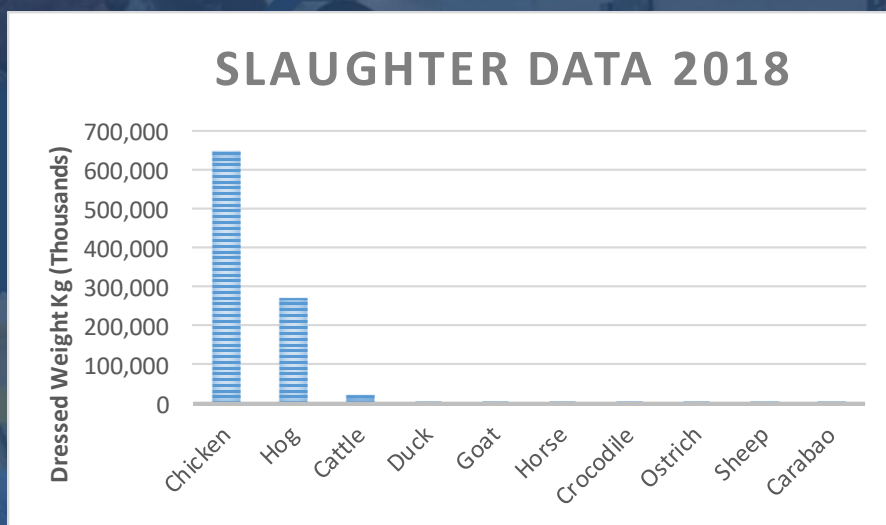


## LICENSING AND CERTIFICATION

- Issued a total of **370** meat establishments with License to Operate (LTO) for the year, of which 50 were classified as AAA and 320 were AA. While a total of **149 products** and **73 meat establishments** were Hazard Analysis and Critical Control Point (HACCP) certified.

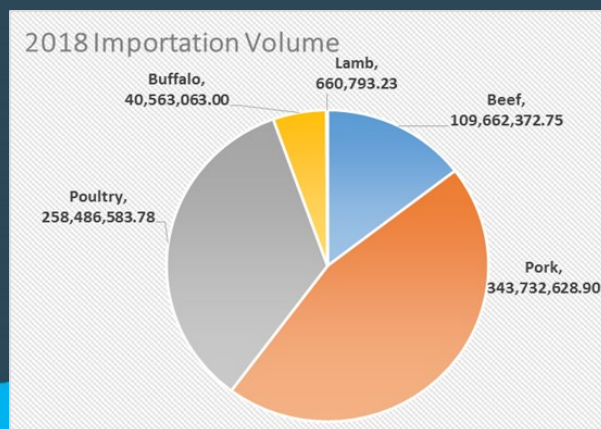

- Issued a total of **3,112,061** sheets of Meat Inspection Certificate (MIC) to inspected meat.
- The inspection on hygienic and humane slaughter of food animals in licensed meat establishments showed chicken, hogs and cattle are the most slaughtered animals. Data showed that chicken meat has the highest volume which is 648,704,774 kilograms (68.8%), while hog is 272,546,052 kg (28.9%) and cattle is 19,788,845kg (2.1%).
- Introduced the **Expert and Prompt Response Event-based Surveillance (ExPRESS)**, a re-entry project creating an event-based surveillance system. The ExPRESS Project was proposed by Dr. Ma. Elaine Joy C. Villareal as a part of her requirement in Masters of Public Management in Development Academy of the Philippines (DAP).



## LABORATORY ANALYSIS

- ✓ The Central Meat Laboratory (CML) tested a total of **28,446** and **3,033** samples under the **pathogen monitoring and veterinary drug residue programs** respectively in support to the regulatory function of the agency as well as the national surveillance program,
- ✓ Conducted a total **18,562 analysis using Microbial Inhibition Test (MIT)** wherein 12 samples exhibited positive results with 4 Macrolides, 3 Aminoglycoside, 1 Beta Lactams, 1 Quinolones, and 3 Tetracycline. While 811 samples were analyzed for Meat Species Identification in which 35 samples indicated positive results with dog DNA and carabeef DNA. There was an over accomplishment for Antimicrobial Resistance Testing due to the intensification of the said program.
- ✓ Tested a **total of 1,999** samples, wherein 1,652 samples were suspected to Ampicillin, Chloramphenicol, Trimethoprim/Sulphamethoxazole and Tetracycline. Testing and analysis for 12 and 274 samples using the meat parasites monitoring and method development for LCMS/MS respectively, wherein no samples indicated positive results. There were 19 samples tested for chemical contamination wherein 3 samples were positive for Nitrite Determination.
- ✓ In preparation towards the ISO/IEC 17020:2012 Certification, an orientation was conducted last March 20, 2018 and laboratory personnel attended several different seminar, training, and workshop and/or to further capacitate their skills. This is to assess its competence in testing and in generating valid results, and thus be deemed as technically competent as statutory requirement of importing countries. This Certification will give the country an opportunity to comply with the importing countries' requirement and export meat.







Inspected a total volume of **753,105,441.65 kilograms** (753,105.44 metric tons) of meat at the 2nd Border Cold Storage Warehouse (CSW). Pork and poultry having the highest volume, comprising 45.64% and 34.32% of total imports respectively.

Accredited a total of **286 meat importers**, issued a total of **4,940 Certificate of Meat Inspection (COMI)** for domestic transport of imported meat and issued **930,768** of Veterinary Quarantine Meat Inspection and Laboratory Certificate (eVQMILC) for imported meat.

Implemented the **2018 NMIS Surveillance** for Indian Buffalo Meat (IBM) and Mechanically Separated/Deboned Meat (MSM/MDM).

There was no export of meat for 2018 due to the Avian Influenza Ban.

# SURVEILLANCE & STRIKE OPERATIONS

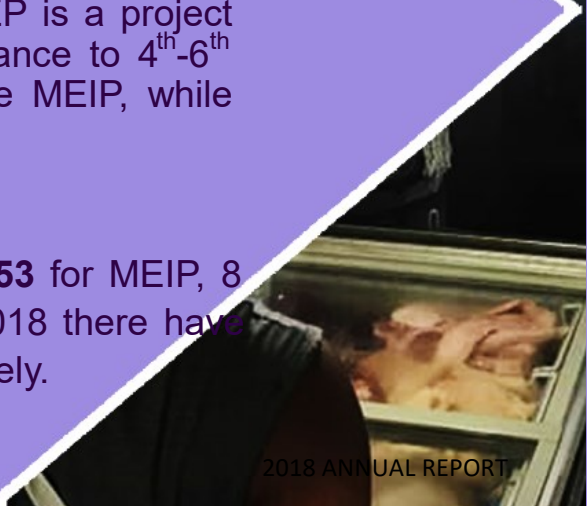
Conducted market surveillance and enforcement regularly but there is an increase in accomplishment due to the intensified enforcement activity as one of the priority activities of the Executive Director to safeguard the consuming public.

Conducted surveillance and monitoring activities in the regions through **Task Force Bantay-Karne (TFBK)** - the main framework of enforcement. A total of **258 surveillance and strike operations** were conducted that resulted to confiscation of **24,947 kilograms of hot meat**.

## ASSISTANCE TO LGU

NMIS provides assistance to LGU thru infrastructure programs and projects such as the following: Meat Establishment Improvement Program (MEIP), Small Scale Meat Establishment Program (SSMEP), and Abattoir Development Assistance (ADA) to LGU. The MEIP is a program (50:50 NMIS-LGU funding scheme) to rehabilitate and/or complete the LGU's meat establishment to comply with the licensing requirements of NMIS. The SSMEP is a project crafted to provide technical and full financial assistance to 4<sup>th</sup>-6<sup>th</sup> class municipalities who cannot be recipients of the MEIP, while ADA provides full financial assistance to LGU.

Provided assistance to **a total 67 LGU recipients; 53 for MEIP, 8 for SSMEP and 6 for ADA**. In total, from 2007 to 2018 there have been 51 and 8 MEIP and SSMEP recipients respectively.





## TRAINING ON MEAT SAFETY FOR LGUS

Conducted a **total** of 36 trainings, with 1,232 participants, for the external clients of NMIS such as the LGUs and Private Sector.

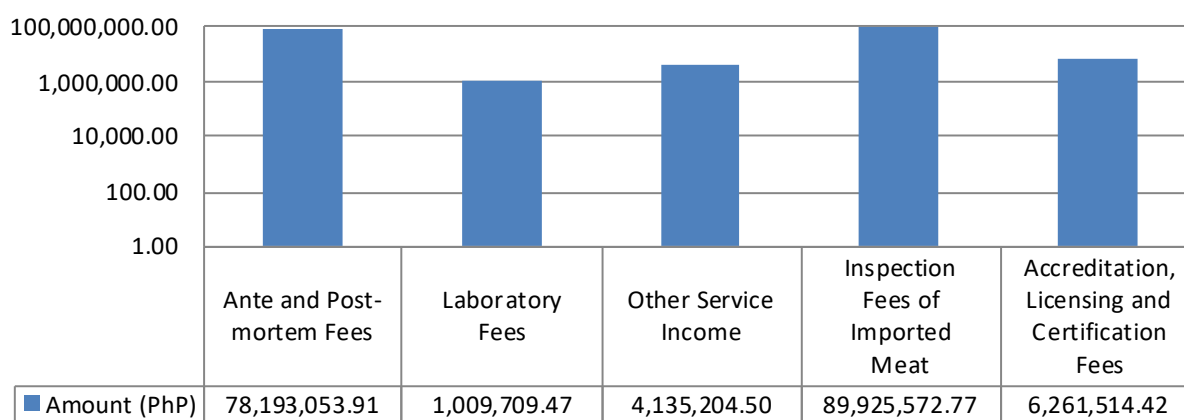

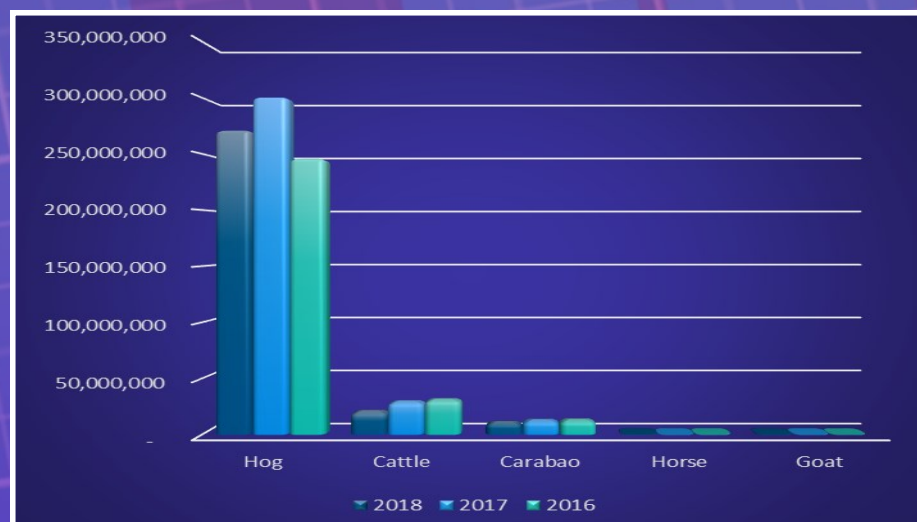

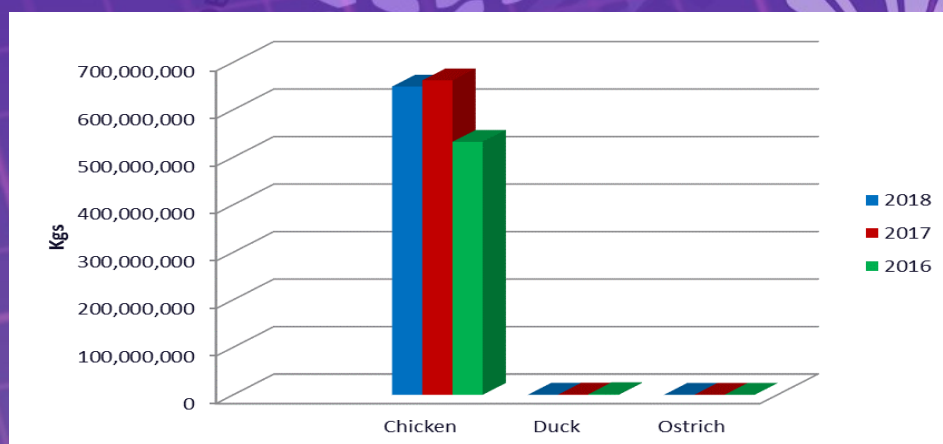

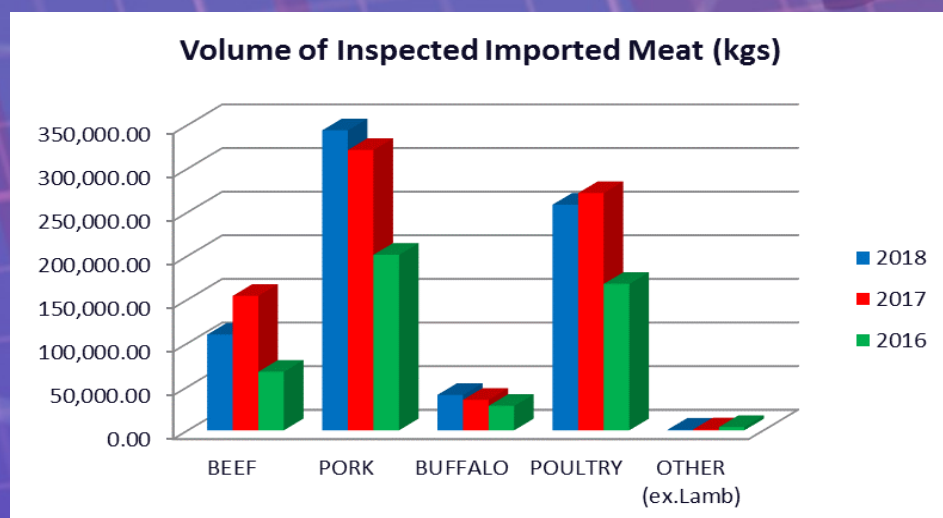
