## BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION No. FB2022-08-07

## BAC RESOLUTION DECLARING FAILURE OF BIDDING UNDER NEGOTIATED PROCUREMENT-TWO FAILED BIDDINGS

WHEREAS, the National Meat Inspection Service advertised the Invitation to Bid for the *Supply and Installation of Acoustic Panel at NMIS SHE Hall Stage Backdrop*, was posted on the NMIS and PhilGEPS websites, and on a conspicuous place on the premises of the NMIS on June 17, 2022, with a total Approved Budget for the Contract (ABC) amounting to *One Million Four Hundred Thousand Pesos (Php1,400,000.00)* under the **(GAA) 2021 continuing fund**;

WHEREAS, the deadline for submission of bid/quotation was on July 5, 2022 (Tuesday) at 1:00 p.m.;

**WHEREAS**, in response to the said advertisements, two (2) prospective bidders purchased the bid documents;

WHEREAS, during the opening of bids on July 5, 2022 (Tuesday) at 1:30 p.m at NMIS Conference Room, two (2) prospective bidders submitted the bid proposal for the *Supply and Installation of Acoustic Panel at NMIS SHE Hall Stage Backdrop*;

WHEREAS, the NMIS-BAC first opened the eligibility and technical documents of **Basic Machinery** and Acoustic Corporation, its itemized content was read as shown through the multimedia projector and found to have **PASSED** the "pass or fail" criteria as specified in the bid documents and was declared "ELIGIBLE";

WHEREAS, the NMIS-BAC proceeded to open the Eligibility and Technical Documents of Macrotech MHZ Trading House and read its itemized content as shown through a multimedia projector. During the evaluation, it was discovered that they did not comply with the following required documents: 1. Non-submission of the statement of all its ongoing government and private contracts, including contracts, awarded but not yet started; 2. The Technical Specifications did not state "Comply or Not Comply"; and 3. Non-submission of Net Financial Contracting Capacity (NFCC) or committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation. Macrotech MHZ Trading House had insufficient requirements and was declared "INELIGIBLE";

**WHEREAS**, the NMIS-BAC proceeded to open the financial documents of **Basic Machinery and Acoustic Corporation**, the financial proposal was opened and read as shown through the multimedia projector;

**WHEREAS**, the following is the bid amount submitted by the participating bidder based on the financial proposal of the bid;

**WHEREAS**, following a thorough review of the financial proposal, **Basic Machinery and Acoustic Corporation** were identified as the single calculated bid. Consequently, the NMIS-BAC instructed the TWG to assist in further evaluating the bid submitted by **Basic Machinery and Acoustic Corporation**;

WHEREAS, on July 6, 2022, the NMIS-BAC, through its Secretariat, sent a Notice of Ineligibility to **Macrotech MHZ Trading House**. They have three (3) calendar days to file a request for reconsideration;

**WHEREAS**, the prospective bidder, **Macrotech MHZ Trading House** did not file a request for reconsideration within the prescribed period given by the NMIS-BAC;

WHEREAS, on July 21, 2022, the Technical Working Group submitted its Post Qualification Report to the NMIS-BAC stating that, based on the re-computation of the prospective bidder's financial bid, **Basic Machinery and Acoustic Corporation**, the corrected bid amount shall be **One Million Five Hundred Twelve Thousand Three Hundred Seventy-Six Pesos and 80/100 only (PHP 1,512,376.80)**, which is **above** the agency's Approved Budget for the Contract (ABC) of **One Million Four Hundred Thousand Pesos (PHP 1,400,000.00)** only. The TWG Evaluation Report is included;

**WHEREAS**, on July 21, 2022, the NMIS-BAC sent a Notice of Post Disqualification to **Basic Machinery** and Acoustic Corporation through its Secretariat;

WHEREAS, the NMIS-BAC did not receive a request for reconsideration from Basic Machinery and Acoustic Corporation during the stipulated period;

NOW, THEREFORE, We, the members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED to declare a *Failure of Bidding under negotiated procurement through two failed biddings* for the Supply and Installation of Acoustic Panel at NMIS SHE Hall Stage Backdrop and repost the opportunity for the same mode of procurement.
